

December 2010 LARE Administration & C/LARE Schedule

The December 2010 administration of the LARE (Landscape Architectural Registration Exams) will include Sections C and E. **To register for the reduced rate, payment and LARE order form (enclosed) must be received by the BCSLA no later than 12:00 NOON PDT FRIDAY, OCTOBER 1, 2010. Late order fees will apply thereafter.**

All new candidates must create a unique Candidate ID on the CLARB website before submitting payments and the LARE Order Form to the BCSLA. Visit www.clarb.org/Candidates/GraphicExams/Pages/RegistrationProcess.aspx for instructions. Select 'BC' as the jurisdiction in which you would like to be initially licensed. You will be redirected to the BCSLA website. Previous exam candidates can omit this step.

Payments must be made separately. The first payment should be endorsed to the **BCSLA** for **\$84.00** (\$75 + 12% HST) for administration. The second payment is to be made out to **CLARB in US funds** by **cashiers cheque or money order only** for the amount of the exam(s) being written. **Exams will not be ordered unless payment is received by the deadline.** Registration confirmations and administration fee receipts will be mailed approximately one month before the examination. Please submit your payments and LARE Order Form (enclosed) to the BCSLA office. Do not send information directly to CLARB.

REDLINE REVIEW ORDERS

CLARB will notify June 2010 exam candidates via email when scores are available on the CLARB website; the email will also provide information about the Redline Review process. Exam candidates must purchase Redline Reviews from CLARB. BCSLA will contact Review Candidates and arrange a time to administer the Review.

C/LARE (Computerized Landscape Architectural Registration Exams)

The dates for the administration of the multiple-choice sections of the LARE (Sections A, B and D) are as follows: **September 13-26, 2010**. Any multiple-choice exam may be taken on any day within the two-week window. Please check availability at the centre where you wish to test to determine the available testing days. The test centres have a limited number of stations available. Spaces are reserved on a first-come, first-serve basis. Candidates are encouraged to register as early as possible to have the best selection of testing centres. Visit www.clarb.org for registration deadlines and costs. BCSLA does not administer this exam but we are happy to assist if you encounter any problems.

STUDY MATERIALS

CLARB and the American Society of Landscape Architects (ASLA) have partnered to provide quality preparation materials to candidates preparing to take the LARE.
