Continuing Education (CE) and the BCSLA

"The Landscape Architect as a Life Long Learner"

At the recent BCSLA AGM held on March 10, 2001, the membership voted overwhelmingly to **approve Special Resolution No. 1**. With the goal of increasing the profile of Landscape Architects in the province and to keep the membership abreast of emerging issues, the BCSLA has established a CE Program and Committee. The Board of Directors is now looking forward to the immediate implementation of a 3 year voluntary trial Continuing Education Program (CE). With the expansion of the current CE Committee the proposal is to implement and monitor the evolution of the "draft" program, working the "bugs" out of the delivery and recording systems over the next three years. **The ultimate goal is to evolve the program, with the full input of the membership, into a Mandatory Continuing Education Program after the 3-year trial stage.**

The program will require that all Full Members of the BCSLA accumulate a total of 30 CE credits over a period of three years. There is a detailed CE Program Guide which outlines four primary categories designed in a manner

which will allow a member to easily collect the required 30 credits. In addition, the BCSLA will be assisting with the delivery and communication of a broad array of CE opportunities. Members who achieve the required points are recognized accordingly.

Professions including Architects, Engineers, Planners and Landscape Architects across Canada and North America are moving toward establishing Continuing Education (CE) Programs to maintain and raise core competency of their members. There are many benefits of being involved in a CE program, one of which is a **greater awareness and respect for Landscape Architecture** by the general public and allied professions.

The BCSLA CE Committee has consulted the recent policy and development work completed by the OALA, the CSLA and other allied professions and would like to thank these organizations for their assistance in the development of our CE Program.

2001 BCSLA Awards

The following individuals and organizations were honored at the 2001 BCSLA AGM for their achievements and dedication to landscape.

BCSLA Community Service Awards

Sylvia Pincott has been an ardent supporter of environmental initiatives in the Fraser Valley. She initiated the *Backyard Habitat Program* in the City of Abbotsford, BC. Ms. Pincott is co-author of *Naturescape British Columbia — Provincial Guide*. She continues to promote Naturescape principles with her writings and presentations. The Naturescape Program is now been adopted in other provinces.

Francis Johnson served on the MacDonald Wood Park Society. The Society successfully raised over 1.5 million dollars to purchase ten acres of waterfront park in the Town of Comox, BC. Ms. Johnson is also a long-time member of the Comox Valley Naturalists. She has written and published local nature viewing and walking guides that are in common use today.

Merve Wilkinson's commitments to the principles of sustainable forests have provided a working demonstration of an alternative to industrial forest management techniques. At 85 years of age he still operates *Wildwood*, a 137-acre tree farm near Ladysmith BC. This forest has been logged using selective cutting methods since 1945. The fact that this forest has been cut over thirteen times is not

readily apparent, since *Wildwood* appears more akin to a nature park than a tree farm.

Martin Thomas, is the Program Manger of the Downtown Revitalization Program with the Ministry of Municipal Affairs, Province of British Columbia. He has managed the various provincial programs aimed at improving the urban places across BC. In more than twenty years of operation, Martin has overseen approximately 300 revitalization projects. Trees that were planted on our downtown streets in the 1980's are now reaching significant sizes and imbuing their locale with great charm

The Universal Public Garden Society began as a commitment to the integration of neighbourhood and hospital needs within the open space concept for the redevelopment of the Vancouver General Hospital grounds. The **Society** fostered the Extended Care Garden and is developing gardens for psychiatric rehabilitation and a therapeutic roof garden for the Burns and Plastics Unit. With the goal of creating an integrated park and hospital, the Society successfully promotes all VGH open space development that supports a healthy, caring community.

The Corporation of the City of Richmond was recognized for consistently creating a high quality environment by integrating landscape architecture projects into the city fabric. Richmond was cited for taking a proactive role in transforming the public realm into a people place with more greenery. The City undertook major projects including the new City Hall, new bus routes to accommodate a rapid bus line and approaches to community gateways.

Gordon Price, Councillor, City of Vancouver, was awarded an **Honorary Membership in the BCSLA** in recognition of his continuing work promoting a dialog on Greenways / Bikeways, pedestrian spaces, the liveable region strategy, sustainable urban design and ALR protection. A 15-year veteran, Councillor Price's advocacy has been instrumental in heightening recognition of the positive benefits of well-planned and well-designed communities.

BCSLA Board of Directors Awards

Cornelia Hahn Oberlander was inducted as a **BCSLA Life Member** in recognition and appreciation of her continued commitment to landscape architecture. She is one of Canada's foremost landscape architects. Cornelia has designed the landscapes of the Museum of Anthropology and the C.K. Choi Building at UBC, the Vancouver Public Library, Robson Square, the National Gallery of Canada in Ottawa, and the Canadian Chancery in Washington, DC to name just a few. In 1990 Cornelia received the Order of Canada. The Royal Architectural Institute of Canada awarded her the Allied Arts Medal in 1995, and she is an honorary member of the Architectural Institute of BC.

Don Barron was named as a **BCSLA Life Member** in recognition of his contribution to landscape

architecture. He has been an active Board member of the Canadian Society of Landscape Architects and served as President in 1995. Mr. Barron was instrumental in the restructuring of the International Federation of Landscape Architects (IFLA) and the CSLA's subsequent re-entry into that organization.

Alan Duncan was recognized with the **BCSLA Public Practice Award**. Working with the City of Vancouver, Alan was instrumental in developing the City's Tree Protection Bylaw, the Greenway Plan, the Trans Canada Trail, Public Art policy, neighbourhood planning involvement strategies, and drafted bylaws with respect to special residential zoning. As an educator, Alan has taught and assisted with numerous studios, workshops and courses at UBC and is now a Sessional Instructor in the UBC Landscape Architecture Graduate Degree Program. Alan is an innovator, pragmatist and leader.

Gerry Eckford was awarded the **Exceptional Contribution Award** for his many and varied roles in advancing the profession of landscape architecture. He recently stepped down from the Board of the Washington DC based Council of Landscape Architecture Registration Boards (CLARB), where he negotiated reciprocity for BC and California landscape architects. Gerry was the first Canadian to sit on the CLARB Board. He is also a past director of the BCSLA and was its Registrar for five years. Gerry teaches at UBC and is the principal of Eckford & Associates Landscape Architects.

The new BCSLA Board of Directors established at the 2001 Annual General Meeting held in Vancouver.

Adrienne Brown succeeded Patricia Campbell Mills as President. Adrienne has been a fully registered member since 1994. The daughter of one of the charter BCSLA members, she is a self-starter who brings a wealth of experience to the post. Adrienne is a sole practitioner who works in North Vancouver.

Patricia Campbell Mills will serve as Past President. During her tenure as President, Pat acted as liaison with the Architectural Institute of BC, was active on the Bylaw Committee — which she will now Chair — the Public and Professional Relations Committee and many other BCSLA initiatives. She is a principal in DMG Landscape Architects.

Peter Kreuk accepted the nomination as President Elect. He has been a full member since

1982 and has served on the BCSLA Board of Directors and as President in 1992. He will Chair the Public and Professional Practice Committee in 2001. Peter is a principal in the landscape architecture firm Durante Kreuk Ltd.

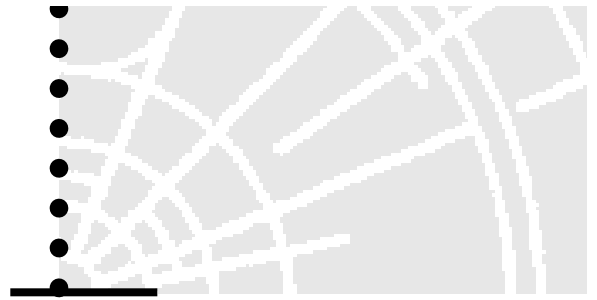

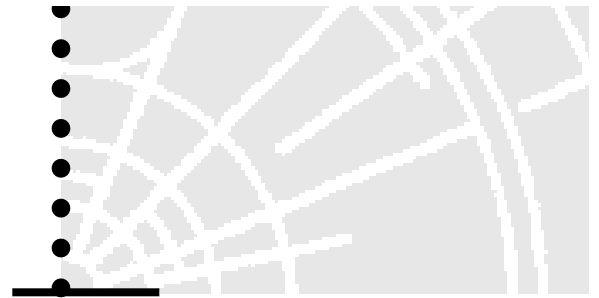

Board of Examiners Q&A

I am providing this "Q&A" sheet to clarify the role of the BCSLA Board of Examiners and the procedure by which the Oral Examination of potential members shall be conducted.

What is the role of BCSLA Board of Examiners?

- To set and administer the examination necessary for the registration

of members in the British Columbia Society of Landscape Architects.

- To review the applicants qualifications and determine acceptability.

Who are the Board of Examiners?

As required by the Architects (Landscape) Act, the Lieutenant Governor in Council appoints a Board of Examiners of not less than five (5) persons:

- a person nominated by the Principal of Kwantlen University College.
- a person nominated by the Director of the School of

Architecture of the University of British Columbia;

- a person nominated by the Dean of the Faculty of Agriculture of the University of British Columbia.
- the President of the Society; and
- a person to represent the public interest in the furtherance and maintenance of proper standards of professional practice in Landscape Architecture in the Province.

The Past President of the BCSLA chairs the Board of Examiners. The Registrar of the BCSLA is not a

member of the Board of Examiners but is responsible for the presentation of all applicants for membership to the Board.

What is expected of me?

Applicants will be expected to review experience, provide a small portfolio of 2 – 3 varied projects and answer any questions related to the professional practice of landscape architecture. They may be asked to discuss their reason(s) for seeking registration and how they would involve themselves in the business of the Society. Minimally, an Applicant must be prepared to demonstrate a working knowledge of the following:

- Mechanics Lien Act
- Contract Administration
- BCSLA Code of Ethics
- BCSLA Bylaws & Procedures
- Insurance

What are the most common areas of candidate weakness?

It is difficult to generalize about a candidate population as diverse as those who come before the Board of Examiners. However, areas of weakness for some of the recent candidates included a working understanding of the Builders' Lien Act, contract administration, insurance (personal and project related) and the preparation of proposals.

How is the Exam Administered?

- A summary of each applicant member is sent to the Board of Examiners two weeks in advance of the sitting of the Board of Examiners.
- The Board of Examiners will meet 1 hour prior to the first scheduled appearance of an applicant to determine the session's specific questions based on the broad topics listed above.
- The Registrar introduces each candidate to the Board.
- The Chair of the Board welcomes the applicant and introduces the Board of Examiners.
- The Chair of the Board reads the prepared statement that explains the objectives of the oral exam.
- The Chair will then ask the applicant to start with a 5-minute review of experience followed by a 5-minute presentation of 2 – 3 projects or portfolio items.
- The Board will then question the applicant to determine their knowledge in the areas noted above. Each Board member will keep notes on responses by applicants. This should be kept to 15 minutes to allow equal time for all candidates throughout the day. Board members are requested to ask questions and probe but not provide answers or lengthy explanations.
- The applicant will then be dismissed and the board will deliberate for 10 – 15 minutes on the success of the applicant. A tentative decision will be recorded by the registrar subject

to an overall review at the end of the days' proceedings.

- The Registrar will be notifying the applicant by phone of the Board's decision the following business day. This will be followed by correspondence clearly outlining any concerns that the Board had with an applicant's examination.

When does the Board of Examiners sit?

A sitting of the Board of Examiners will be held twice per year (spring & fall) if warranted by the number of applicants.

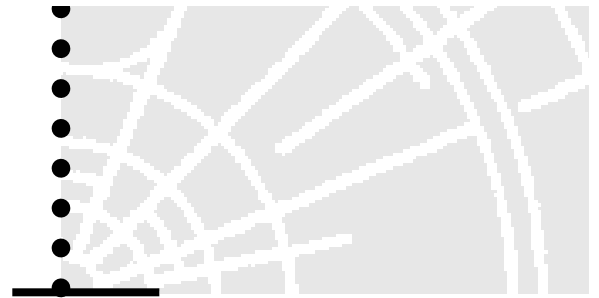
Would you share the prepared statement read by the Board Chair at the beginning of an exam?

"The examination will be as objective as possible and is intended to determine your competence (or weak points) relative to Landscape Architectural practice in British Columbia. Having **current knowledge of conditions of practice** required to allow an individual to **run their own office competently** is our basic **criterion for deciding whether or not you will be granted registration**. We do not require that you be an expert in all facets of Landscape Architecture, but that you have the ability to clearly articulate your beliefs or your knowledge. However, if you are lacking in some of these areas, you must be able to demonstrate a mature and realistic approach to solving the everyday problems of the practicing Landscape Architect."

I trust that this has been helpful.

2001 BC LANDSCAPE STANDARD

The **6th edition** of the **BC Landscape Standard** is now available from the BCSLA office.
